- 5. All circuits connected to the device must comply with the overvoltage category II (or better) according to IEC/EN 60664-1. The device may only be used in an area of not more than pollution degree 2 (or better) according to IEC/EN 60664-1.
- 6. The barriers are rated `non-incendive` for use in Class I, Division 2 or Zone 2. A temperature rating of T4 applies to all non-incendive rated barriers.
- 7. If the barriers are intended to be mounted in a Division 2 location, they shall be mounted within a tool-secured enclosure which is capable of accepting one or more of the Class I, Division 2 wiring methods specified in the National Electrical Code (ANSI/NFPA 70) or Canadian Electrical Code (C22.1), as applicable. The equipment shall be installed in an enclosure with a minimum ingress protection of IP2X.

If the barriers are intended to be mounted in a Zone 2 location, they shall be mounted within a tool-secured enclosure which is capable of accepting one or more of the Class I, Zone 2 wiring methods specified in the National Electrical Code (ANSI/NFPA 70) or Canadian Electrical Code (C22.1), as applicable. The equipment shall be installed in an AEx or Ex certified IP54 enclosure in accordance with UL/CSA 60079-0 unless the apparatus is intended to be afforded an equivalent degree of protection by location.
