2. Simple apparatus: an electrical component or combination of components of simple construction with well-defined electrical parameters that does not generate more than $1.5 \mathrm{~V}, 100 \mathrm{~mA}, 25 \mathrm{~mW}$, or is a passive component that does not dissipate more than 1.3 W and is compatible with the intrinsic safety of the circuit in which it is used.
3. Wiring methods must be in accordance with all applicable installation requirements of the country in use. For US, this is NFPA 70 (NEC) article 504 with additional information in ANSI-ISA -RP12.06.01. For Canada this is CSA 22.1-12 (CEC) section 18 and appendix F. 8. The barriers are rated "Non-incendive". A temperature rating of T4 applies to all non-incendive rated barriers.
9. In Class I, Division 2 and Class I, Zone 2 installations live maintenance is not permitted.

If the barriers are intended to be mounted in a Division 2 location, they shall be mounted within a tool-secured enclosure which is capable of accepting one or more of the Class I, Division 2 wiring methods specified in the National Electrical Code (ANSI/NFPA 70) or Canadian Electrical Code (C22.1), as applicable. The equipment shall be installed in an enclosure with a minimum ingress protection of IP2X.

The equipment shall be installed in an AEx and EX certified IP54 enclosure unless the apparatus is intended to be afforded an equivalent degree of protection by location. The IP54 enclosure must meet the requirements of UL/CSA 60529 and UL/CSA 60079-0.
