15 Description of Equipment or Protective System

The Transformer Isolated Resistance Repeater Type HiC2077 is designed to transfer a voltage signal from a hazardous area to unspecified apparatus located in a non-hazardous area. The hazardous area circuit is galvanically isolated from the non-hazardous area circuit using transformers and the voltage and current appearing at the hazardous area connection pins is limited to intrinsically safe levels.

The Transformer Isolated Resistance Repeater Type HiC2077 comprises a number of electronic components including three isolating transformers, fuses, zener diodes and resistors all mounted on a single printed circuit board and housed in a plastic enclosure with two polarised sockets in the base of the enclosure for hazardous and non-hazardous area connections via a terminal backplane. LED indication is provided for power-on status.
