# 11 Description

The RSM-Ex 01 BT is an intrinsically safe remote speaker microphone. The connection to the smartphone or further sources is realized by Bluetooth. The integrated loudspeaker is very powerful and allows clear communication even inside very harsh and noisy industry areas. It is a hand held device. The mounting on the user via belt clip is also possible. Power is supplied by a Li-ion battery, which is permanently installed in the device. Charging must take place outside the hazardous locations. Optionally, approved headsets can be used with this device.

The RSM-Ex 01 has a jack connector where a headset can be connected. Following headsets are approved and allowed to be connected to RSM-Ex 01BT:

-ComCom Ex and additional in-ear plug Serenity SPC Ex

- RSM HS 01 -W

- RSM HS 01 -B

The approved headsets are allowed to connected and disconnected directly inside the Ex-area.

## 14 Specific Conditions of Use

The following conditions relate to the safe installation and/or use of the equipment:

- i. Do not charge or open the device inside the Ex-area
- ii. It must be ensured that the maximum input voltage (Um) for the device from the charger between the lines is 6V The ambient temperature during the charging shall be in the range from 0 °C to +45 °C
- iii. Do not use the device in zone 20
- iv. When using the device with Retractable Lanyard RL ID01 avoid strong charge generating processes for using in mining zone only
- v. The device must be protected against strong impacts for Group I. The device must be protected against the constant contact with oils, hydraulic liquids and fats.
