DAMAGE, PACKING AND INSURANCE

We do not accept responsibility for goods damaged in transit. Facts relating to damage should be reported to the Carriers with copy to ourselves within three days of the receipt of the goods.

CARRIAGE, PACKING AND INSURANCE

Carriage, Packing and Insurance will be charged extra except where specifically stated otherwise on our acknowledgement.

PRICES

Prices charged will be those ruling at the date of despatch. Prices are subject to change in January each year.

TERMS

Nett monthly.
Pepperl+Fuchs GB Ltd reserve the right to charge interest from the date when payment become due at a daily rate calculated at 2% above H.S.B.C. base rate and will be charged at such a rate after as well as before any Judgement.

GUARANTEE

The liability of the company is limited to the repair or replacement of goods showing defects arising solely from faulty materials and/or workmanship. The liability is for one year from the date of despatch of the goods from the Company's works. All other warranties whether implied by statute or common law or otherwise are excluded. PAYMENT TERMS

INVOICES
