# **Instruction Manual**

#### 1. Marking

## 2. Validity

Specific processes and instructions in this instruction manual require special provisions to guarantee the safety of the operating personnel. Observe laws, standards, and directives applicable to the intended use and the operating location. Observe Directive 1999/92/EC in relation to hazardous areas.

The corresponding datasheets, manuals, declarations of conformity, EU-type examination certificates, certificates, and control drawings if applicable (see datasheet) are an integral part of this document. You can find this information under www.pepperl-fuchs.com.

#### 3. Target Group, Personnel

Responsibility for planning, assembly, commissioning, operation, maintenance, and dismounting lies with the plant operator.

The personnel must be appropriately trained and qualified in order to carry out mounting, installation, commissioning, operation, maintenance, and dismounting of the device. The trained and qualified personnel must have read and understood the instruction manual.

#### 4. Intended Use

The device is only approved for appropriate and intended use. Ignoring these instructions will void any warranty and absolve the manufacturer from any liability.

The device must only be operated in the specified ambient temperature range and at the specified relative humidity without condensation.

Only use the device stationary.

The backplane connections are non-intrinsically safe.

## 5. Improper Use

Protection of the personnel and the plant is not ensured if the device is not used according to its intended use.

The device is not suitable for isolating signals in power installations unless this is noted separately in the corresponding datasheet.

## 6. Mounting and Installation

Observe the instruction manuals for the associated backplanes.

Do not mount the device at locations where an aggressive atmosphere may be present.

The device must be installed and operated only in an environment that ensures a pollution degree 2 (or better) according to IEC/EN 60664-1. If used in areas with higher pollution degree, the device needs to be protected accordingly.

All circuits connected to the device must comply with the overvoltage category II (or better) according to IEC/EN 60664-1.

Do not mount a damaged or polluted device.

Only use accessories specified by the manufacturer.

Observe the installation instructions according to IEC/EN 60079-14.

## 6.1. Requirements for Surrounding Enclosures

Ensure that the surrounding enclosure is not damaged, distorted, or corroded.

Ensure that all seals are clean, undamaged, and correctly fitted.

Tighten all screws of the surrounding enclosure/surrounding enclosure cover with the appropriate torque.

For cable glands only use incoming cable diameters of the appropriate size.

Tighten all cable glands with the appropriate torque.

Close all unused cable glands with the appropriate sealing plugs.

#### 6.2. Requirements for Non-Hazardous Area

The device must be installed and operated only in surrounding enclosures that

- comply with the requirements for surrounding enclosures according to IEC/EN 60079-0,
- are rated with the degree of protection IP54 according to IEC/EN 60529.

Alternatively, it is permitted to install and operate the device in a controlled environment that ensures a pollution degree 2 according to IEC/EN 60664-1.

#### 6.3. Requirements for Equipment Protection Level Gc

The device must be installed and operated only in surrounding enclosures that

- comply with the requirements for surrounding enclosures according to IEC/EN 60079-0,
- are rated with the degree of protection IP54 according to IEC/EN 60529.

#### 6.4. Requirements for Cables and Connection Lines

Observe the permissible core cross-section of the conductor.

The insulation stripping length must be considered.

When installing the conductors the insulation must reach up to the terminal.

When using stranded conductors, crimp wire end ferrules on the conductor ends.

Never pull the cable. A wire could become loose from the terminal and protection against electric shock can no longer be ensured. Always pull the terminal.

Unused cables and connection lines must be either connected to terminals or securely tied down and isolated.

#### 6.5. Requirements for Usage as Associated Apparatus

If circuits with type of protection  $\mathsf{Ex}$  i are operated with non-intrinsically safe circuits, they must no longer be used as circuits with type of protection  $\mathsf{Ex}$  i.

Intrinsically safe circuits of associated apparatus (installed in non-hazardous area) can be led into hazardous areas. Observe the compliance of the separation distances to all non-intrinsically safe circuits according to IEC/EN 60079-14.

Observe the compliance of the separation distances between two adjacent intrinsically safe circuits according to IEC/EN 60079-14.

Observe the respective peak values of the field device and the associated apparatus with regard to explosion protection when connecting intrinsically safe field devices with intrinsically safe circuits of associated apparatus (verification of intrinsic safety). Also observe IEC/EN 60079-14 and IEC/EN 60079-25.

## 7. Operation, Maintenance, Repair

Substitution of components may impair intrinsic safety.

Substitution of components may impair suitability for Zone 2.

Do not use a damaged or polluted device.

Only use accessories specified by the manufacturer.

Do not repair, modify, or manipulate the device.

If there is a defect, always replace the device with an original device. Observe IEC/EN 60079-17 for maintenance and inspection of associated apparatus.

#### 8. Delivery, Transport, Disposal

Check the packaging and contents for damage.

Check if you have received every item and if the items received are the ones you ordered.

Keep the original packaging. Always store and transport the device in the original packaging.

Store the device in a clean and dry environment. The permitted ambient conditions must be considered, see datasheet.

Disposing of device, packaging, and possibly contained batteries must be in compliance with the applicable laws and guidelines of the respective country.
